On February 9, 1998, according to the Prime Minister's Decision No. 30/1998/QD-TTg, the school was named Banking Academy - Ho Chi Minh City Branch. On August 20, 2003 the Prime Minister signed the decision No. 174/2003/QD-TTg to establish the University of Science and Technology of Ho Chi Minh City.
